Dear Secretary Foxx:

I write to urge the Department of Transportation (DOT) and the Administration to expedite and complete the review of the Federal Aviation Administration's (FAA) Notice of Proposed Rulemaking (NPRM) regarding third-class medical certification within the next 30 days.

As you may know, this NPRM would expand a successful program long used by light sport aircraft users to allow a limited number of general aviation pilots to use a driver's license instead of a third class medical certificate to demonstrate fitness to fly. For certain low-risk types of flying, a FAA third-class medical certificate poses an unnecessary bureaucratic hurdle for Alaska pilots. One of the reasons I founded the Senate General Aviation Caucus was to help ensure federal agencies responded to common-sense ideas like this from the general aviation community. I encourage DOT to work review this NPRM within the next 30 days.
